I think it is fair to say that the last 18 months have been a challenge and has seen many of the nursing staff involved in stroke taking on new roles and being deployed into other posts. As I am sure you are all aware during this time the SSNF has continued to meet and we have strived to keep you informed of what has been going on. This has not always been easy. Not only due to COVID but because of the switch for many from nhs.net to nhs.scot.

The Scottish Stroke Improvement Report

(https://publichealthscotland.scot/publications/scottish-stroke-improvementprogramme/scottish-stroke-improvement-programme-2021-national-report/ts) reflects the impact that COVID had in 2020 but also reflects the hard work that stroke teams have put in to keep their services up and to meet the stroke standards.

We have in the last year seen some innovative developments. Link and Learn sessions on every second Tuesday lunchtime have been a great success. There has been a wide diversity of presentations including the opportunity to ask questions to Jason Leitch, National Clinical Director of Healthcare Quality and Strategy and of course on the 31st Aug 2021 I presented on behalf of the SSNF a summary of our history, our work-plan and the opportunity to recruit further members. This raised some questions about our profile / recruitment/ committee members and on the back of this there will be discussions about how to further improve our profile at our November meeting.

Thanks to Katrina McCormick we have managed to continue to produce our Newsletter twice a year. If you have something interesting happening in your area please get in touch and we can help you produce an article for the Newsletter. We would love to hear from you and your nursing team.

Our Scotland wide thrombectomy service will undoubtedly be part of the new Stroke Improvement Plan from the Scottish Government and we will share this with you as soon as it is published (likely to be 2022). Meanwhile the Thrombectomy Pilot Study continues in Tayside. The transfer paperwork that the SSNF helped to developed is being used and also assessed as part of the study along with the role of the stroke transfer nurse. CHSS trainer Amanda Johnston, an SSNF member, has delivered STAT plus training across the Health Boards helping to up-skill and prepare stroke nurses for this new and exciting role. The funding for new stroke nurse posts has been agreed and the SSNF look forward to engaging and supporting the nurses in these new roles.

The SSNF invites you to join us at our committee meetings if you would like to see what goes on. We have 3 committee subgroups that you are welcome to join, Communication (including conference planning), Education and Research.

Many of our members have been involved in updating of the STARs / stroke training website (<u>www.chsselearning.org.uk</u>) and this work continues. Take a look at the changes and take time to revisit these and complete them as part of your e-learning / revalidation.

Finally thank-you to all the committee members past and present for their hard work and to all our members for your on-going support without you the SSNF would not continue to thrive.

CHSS Education



At Chest Heart & Stroke Scotland, we believe that sharing knowledge and experience is key to ensuring that people living with our conditions get the best care possible.

Our programme of education provides a high-quality learning experience for professionals from the health, social care, third and voluntary sectors. We use a blended learning approach, utilising a range of educational formats and digital resources to provide both functional and flexible learning opportunities.

National Education

Funded by a partnership with the Scottish Government, the National Educator provides national stroke training to healthcare professionals across Scotland. The current focus of the National Educator is to deliver Thrombectomy education, supported by the Scottish Ambulance Service, to registered stroke nurses who will be involved in thrombectomy care in Scotland.

The education team also deliver our national Link Up and Learn virtual education sessions which provide training to healthcare professionals involved in, or with an interest in, stroke care. Delivered in partnership with the Scottish Stroke Improvement Programme, these one-hour sessions take place fortnightly and cover a wide range of topics from colleagues working in stroke care, with time for discussion and knowledge sharing. These sessions have so far had just under 1500 attendees to sessions and over 300 watching the session recordings.

Local Education

Chest Heart & Stroke Scotland, in partnership with local NHS Boards, deliver local stroke training programmes aimed at healthcare professionals, social care staff and care home staff. We currently have a Stroke Educator in NHS Fife and NHS Grampian. A variety of training courses are available which range from introductory level to advanced and give access to the training required to meet the National Stroke Education Pathway, this includes Stroke and TIA assessment training and use of intermittent pneumatic compression stockings. The training is designed to meet the needs of the learner and ranges in delivery from 1 hour awareness sessions to two full day courses. Training can be designed specifically for an area on request.

eLearning

The Chest Heart & Stroke Scotland eLearning portfolio is commissioned by Scottish Government.

Our eLearning portfolio contains learning for healthcare professionals, patients and carers, covering chest, heart and stroke conditions. These free-to-access online resources have been created by multi-disciplinary healthcare professionals, patients and carers from across Scotland. The professional resources have optional assessments which, if successfully completed, provide certificatory documentation of learning that can be used as evidence of continuous professional development.

SSCA Update

The Scottish National Audit Programme governance process was completed as well, with all negative outliers, i.e. those that were 2 or 3 standard deviations out with the mean, or those where there has been no improvement, have all responded and are working to improve their service.

• The national meeting moved to an online only meeting, due to escalating pressures on clinical staff and was very well attended, with over 120 joining the meeting. The presentations and videos are available on the TEAMS page, and if you would like access, just ask.

• The annual review process has commenced, and all health boards, with 2 exceptions, have dates in the diary. These should be complete by the end of the year.

- Data collection for thrombectomy has commenced in the Royal Infirmary of Edinburgh, and also Ninewells have been collecting the data for some time.
- Standards for thrombectomy will be agreed at the next steering group, and will then come to the Thrombectomy Advisory Group and then NACS for approval

• We are continuing to review the outpatient dataset, and quality assurance work, including SMR01 and gaps in data collection is also progressing.

Following on from the update of the progress of eLearning in the spring SSNF newsletter I can confirm that most of the content of the 37 STARs resources have now been updated. Some still require 'finalised' with changes to the quizzes/images/interactive content of individual resources. The group have been very busy and have already agreed all updated content required for the Core Competency and have started on the advancing module.
